The unique provision of Jammu and Kashmir has assemble of 6 years term but other states they have 5 years assemble term. The flag of jammu and Kashmir is unique. The citizen of jammu and Kashmir cannot go in to crime even when they are insulting the Indian national flag and national symbols. The citizens of jammu and Kashmir cannot have any compulsion to obey the supreme court orders. REVOKING ARTICLE 370
